2. Most of the departments have been equipped with computer and internet facility.
3. Encouragement is given to faculty members to attend international/national conferences/symposia/seminars.
4. Some teachers have their established linkages with Indian and foreign research institutes and universities.

1. Grants are provided to each department for purchasing recent publications of reference books and also research journals.
2. The library is also well equipped with required titles and several volumes of text books, , computer hardware and software for conducive learning.

- The institute takes care of its human resources. Employees are given due importance and their needs are recognized. The service rules are made transparent and they are benefited with PF, Gratuity, GSLI etc.
- The faculty and staff are entitled with other benefits like Casual Leave, Earned Leave, Medical Leave, Study Leave etc. Salary is credited to the salary account of the employees on the last working day of every month.
