Article 1

OBJECTIVE OF COOPERATION

The objective of this Memorandum of Understanding (MOU) is to cooperate in educational projects in areas of mutual interest.

Article 2

SCOPE OF COOPERATION

- e. Access of students of both institutions to quality enhancement programme organized at both the institutions,
- f. There will be exchange of classes between two colleges .

Article 3

FINANCIAL ARRANGEMENT

Any cooperation under this MOU is subject to the availability of funding sources and approval by relevant authorities.

Article 4

LOCATION OF ACTIVITIES

1. The Parties agree to implement the programme stated in Article 2 at both the colleges.
2. Any changes of the location of the programme shall be mutually agreed upon by the Parties.

Article 5

MODE OF CONDUCTING THE programme

The programme will be conducted primarily in the Offline mode. Ample arrangements should also be made to conduct programme in the online mode.

Article 6

DURATION AND TERMINATION

- 1) This MOU shall enter into force on the date of signing.
- 2) The MOU shall remain in force for a period of five (5) years and may be extended another period of five (5) years by the mutual written consent of the Parties.
- 3) Either Party may terminate this MOU at any time by giving written notification to the other Party on its intention to terminate this MOU, six (6) months prior to the date of the termination.
- 4) The termination of this MOU shall not affect the completion of any project's and programme's in progress and not completed at the time of termination,


